### ENROLLMENT FEE:

\$40 registration fee per student + due at time of registration to hold a space in a class. The registration fee is non-refundable.



### CONDITION OF ENROLLMENT

The payment of tuition is a condition of enrollment. The enrollment is binding on the parents(s) or legal guardian when signed and submitted to EFSAC but is subject to final acceptance by EFSAC. The obligation to pay tuition for the full year is unconditional notwithstanding the subsequent absence for any reason of the student. It is understood that even though the tuition may be paid in three different installments; this does not constitute a divisible contract. In the event of nonpayment on any amount due, EFSAC may in its sole discretion deny enrollment. This agreement shall be interpreted in accordance with the laws of the state of California. EFSAC reserves the right to place students in classes judged most appropriate for them

**The deadline for the tuition payment is 2 weeks prior to the start of your site's academic term.** A waiting list will be created as needed. We do not ask for the entire year's tuition up front, you can also do two installments or seven installments (See payment option). However, **we do ask for a year-long commitment** to EFSAC class. Learning a foreign language is very fun and enriching, but does require time to expose your child to the language. If you enroll in an EFSAC class, we are sincerely planning on having your child acquire some degree of French fluency and prepare them to the French diploma. We want to set your child up for success in French by asking you and your child to carefully consider whether or not you can make that commitment to plan on attending class regularly for the entire school year.

### MID YEAR REGISTRATION

We strongly encourage you to register your child at the start of the school year to give them the best chance for success in learning French. If your child starts mid-year when the rest of the students have already covered a certain amount of curriculum, he or she may be unable to catch up and feel discouraged. However, if your child switches schools mid-year or if he or she already has some French exposure, it may be possible to register mid-year. Please contact your local site



coordinator to discuss. Tuition payments will be pro-rated, but the registration fee and initial deposit will remain \$70 per family.



### LATE FEE

EFSAC is a non-profit organization operating on limited funds and where board members volunteer their time. To allow us to guaranty a proper operation of the organization, we ask that you do your best to make tuition payments on time. A late fee of \$25 per week will be applied and \$35 for returned check. Also, if your payment is late, your child may not be allowed to participate in the class. If you are facing serious financial difficulties, please do communicate your situation to a board member so we may discuss a solution.



### CANCELLATION

Tuition is not refunded if a student is absent, withdrawn or dismissed from the program before the end of the school year. This is a year-long program and it is understood that tuition is due for the whole year.



### WAIVER OF LIABILITY
